# "Decoding Noncompliance: Are Politicians' Delinquent Financial Disclosures Informative?" Co-authored with Brandon Cline

This paper examines whether U.S. senators strategically violate the STOCK Act's reporting requirements to profit from private information. Analysis of open market transactions reveals that 41.08% of trades are disclosed after the legal deadline. Senators earn significantly higher abnormal returns on purchases reported late and significantly reduced losses on sales, evidence consistent with informed trading. Over a 10-day window after trades, violation purchases earn 0.27% higher and sales 0.32% lower than their non-violation trades. These results are statistically and economically significant and robust to alternative event windows, return measures, and empirical specifications. Violations are significantly more pronounced in trades with high information asymmetry and conflicts of interest, such as those related to senators' committee jurisdiction and stealth trading patterns. Overall, these findings highlight ethical concerns about senators' conflicts of interest and the need for stronger regulatory enforcement and stricter penalties to deter opportunistic trading and improve efficiency in financial markets.

## "Politician Personal Misconduct and Congressional Insider Trading"

This paper examines whether signals of integrity in a politician's personal life relate to opportunistic informed trading. Using a hand-collected dataset on U.S. senator' personal misconduct and open market transactions from 2012 to 2022, we document a significant association between personal misconduct and abnormal trading performance. Specifically, senators with a recorded history of personal misconduct earn, on average, 76 basis points higher abnormal returns on purchases and avoid losses of 49 basis points on sales over the 30-day period following their trades, relative to senators without such misconduct. These results are statistically and economically significant and remain robust across various abnormal return measures, event windows, and matching methods. We also find that senators with personal misconduct are 14.6% more likely to violate the STOCK Act's disclosure requirement when reporting purchase trades. Overall, the results suggest that senators who act unethically in their personal lives are more likely to engage in opportunistic informed trading.

## "Impact of Board Composition and Activity on Non-Performing Loans"

Co-authored with Trang Doan and Chandra Chahyadi

This paper examines the impact of board composition and activity on bank non-performing loans (NPLs). The empirical evidence suggests that NPLs are negatively related to board independence, separation between the CEO and chairman roles, directors with financial expertise, and the frequency of committee meetings. Additionally, we find that, during the financial crisis period (2008–2009), a large board size and the presence of female directors may also help lower NPLs. The results support the hypothesis that shareholder-friendly bank boards and active boards are more effective monitors and thus help lower bank's NPLs.
