### FORT RUCKER UNION DONATES \$3,000 TO GREATER TSUD DEVELOPMENT FUND

The International Association of Machinists and Aerospace Workers, Local Lodge 2003 of Daleville, contributed its largest donation ever recently with a gift of \$3,000 and a plaque to officials of Troy State University at Dothan and The Greater TSUD Development Fund.

The presentation was accepted by TSUD President Thomas Harrison at the April 4 meeting which was also attended by Dr. Jack R. Sublette, Vice President for Student Affairs and Development at TSUD, and Al Childs, the chairman of the Regional Counties subcommittee of the fund drive and an administrative assistant for development at the University.

"Our people believe that we are better on our jobs because of how we educate our children and the education we give them," said R. O. Smith, President of Local 2003 of the union's decision to contribute to the drive.

Harrison graciously accepted the money and told the group that their donation was special to the TSUD cause. "This \$3,000, coming from outside Dothan and outside of any personal interest that anyone might have, is one of the most exciting things that has happened to us. This is tremendous in that you who represent the working people of America, the backbone of society, are committed to a university that wants to provide a quality education for those people who work and attend classes at the same time.

"This \$3,000 will go a long way in ensuring that the construction of our new campus is going to begin."

## TSUD PROVIDES TUITION WAIVER FOR ADULTS RETURNING TO SCHOOL

Adults who have been out of school for a while may find Troy State University at Dothan to be an inviting place beginning with the Summer Quarter in a new University program known as OWLS.

The Older, Wiser Learners' Scholarship has been established for any adult meeting the qualifications to register for one course tuition-free. "OWLS will allow any adult who has not attended a high school, college, or a university for at least three calendar years to enroll tuition-free for one academic course," stated Dr. Jack R. Sublette, the Vice President for Student Affairs and Development at TSUD. "Students will be permitted to register on a space-available basis for a course of their own choosing from the regular schedule of TSUD credit offerings."

The only credit courses that are not open for the OWLS program are those having pre-requisites and those with a limited enrollment. OWLS will be available to individual adults only once.

"TSUD hopes to use this program as a way of motivating adults who have been out of school to return to the classroom," Sublette said. "Once they get back into the academic environment, we hope to see these older, wiser learners complete their education."

Students interested in the OWLS program must apply for admission to the University and submit all required materials.
