RESULTS OF SDE REVIEW POSITIVE

The Alabama State Department of Education recently conducted a review of the Troy State University at Dothan School of Education and has returned a favorable evaluation of TSUD's teacher preparation programs. According to Dr. Betty Kennedy, Dean, School of Education, all state colleges and universities must have their teacher preparation programs approved by the SDE in order for their graduates to be certified. This assures that all students who earn teaching degrees receive an education that is comparable in quality to any in the state.

The SDE review is con-

ducted in five basic steps: (a) the university under review conducts a self-study, (b) the SDE review team spends three days with the university, (c) the SDE makes recommendations and suggestions on improving the university's teacher preparation programs, (d) the university responds to those recommendations, and (e) the SDE presents the university's programs to the State Board of Education for approval.

According to Dr. Kennedy, the SDE report on TSUD's teacher preparation program was very positive. "Overall the SDE felt that our program

was extremely strong and met with all of their standards. They saw nothing that would hinder our students from receiving a solid education," she said. In particular, TSUD was commended for: (a) the cooperative spirit that exists between the School of Education and the College of Arts and Sciences, (b) TSUD's commitment to retaining quality instructors, (c) placing the most emphasis on teaching, (d) the solid support students expressed for TSUD during student interviews, (e) the willingness of the faculty and staff to help students make wise career decisions, and (f) the fact that faculty members from both the School of Education and the College of Arts and Sciences personally supervise student internships. The SDE also made recommendations for improving the strengths of TSUD's basic teacher preparation programs.

"I am extremely pleased with the very positive response the TSUD School of Education received from the State Department of Education. It is a reflection of the quality programs and outstanding faculty and staff we have in the TSUD School of Education and College of Arts and Sciences," said Dr. Kennedy. She added, "I am especially appreciative to the faculty and staff in Education and Arts and Sciences for their dedication to teaching, their commitment to seeing the self-study completed as required, and their overall enthusiasm for what we are about."

SCHOOL OF BUSINESS INTERNSHIP PROGRAM

Students enrolled in Troy State University at Dothan's School of Business now have the opportunity to gain valuable on-the-job experience while they are still in school through the TSUD School of Business internship program. TSUD juniors or seniors majoring in accounting, marketing, management, economics, or computer science and who have earned 30 credit hours at the university are eligible to apply. All applicants must have a 1.75 grade point average on a 3.0 scale and must provide three references. Once the student passes this screening process, he is assigned to a reputable local business. If the business decides to hire the student, that business is obligated to keep the student for three months and pay at least minimum wage. The student is expected to work a minimum of ten hours a week and is eligible to take part in the program three times. The student may earn three credit hours as an intern. Throughout the internship period, the student, TSUD business faculty, and the company supervisor work together to ensure that the student is doing work that is relevant to his major. The student intern is also periodically reviewed by both his faculty and company supervisors.

UPDATE: CONSTRUCTION OF NEW CAMPUS AHEAD OF SCHEDULE

The work on TSUD's new campus is progressing ahead of schedule, according to Gene Murphree. "We are extremely pleased with the rapid progress being made on our new campus. All of the steel has been laid for building "A," the cupola has been erected and it has been topped off. Building "B" should be topped off by the end of the month," he said. Building "A" will be a 37,524 square foot administration/classroom building, while the 42,990 square foot building "B" will house classrooms, laboratories, and the library.

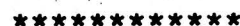


The Office of Recruiting and Student Activities is
