## SELFHELP FUND DRIVE EXCEEDS EXPECTATIONS

In a time of proration and economic stagnation, officials at Troy State University at Dothan have taken a problem and turned it into a positive and motivational venture. For the past two months, TSUD has been involved in its own Self Help Fund Drive to raise funds for the support of projects and critical needs that enhance the University's academic program.

Upon completion of the fund drive, TSUD personnel had contributed \$17,500.00, which exceeded the expectations of University officials. With matching funds from the TSUD Foundation, the Self Help Committee will be working to allocate \$35,000.00 to benefit programs and services at the University.

"The response was tremendous and reflects the morale of faculty and staff on the TSUD campus," stated Dr. Thomas Harrison, TSUD President. "It reflects the commitment of our personnel to the mission of the institution and the growth and development of our academic programs and services," Harrison added. The Self Help Fund Drive will be an annual event that will bring significant development to the life and operation of TSUD.

Dr. Betty Kennedy, Dean of the School of Education and chair of the Self Help Committee, said, "It is evident that the TSUD family supports quality education for the citizens of

the Wiregrass service region. These funds will be allocated in areas of greatest need and in areas that will benefit our students the most."

"The response from this fund drive is a true indicator of the positive climate and high morale found on this campus," remarked Mo Erkins, Assistant to the Vice President for Student Affairs and Development at TSUD. "It shows that we are willing to go into our pockets to meet critical funding needs not provided by state funds," added Erkins.

The Self Help Committee will meet to allocate all funds as soon as possible to ensure that TSUD's students experience the rewards of the commitment made by faculty and staff to quality education.

## TSUD RECOGNIZES CONTRIBUTORS

Through a recent fund drive, the Continuing Education Program at Troy State University at Dothan has been able to equip a computer laboratory for its location at Northside Mall. The laboratory is equipped with twenty IBM computer stations, which offer the latest in technology and training. The IBM Model 44SX/386 control units contain 4MB of RAM and an 80MB hard drive. At a cost of \$48,000.00, the computer lab reflects the commitment of TSUD and area businesses and industry to meet the increasing requests for services, training, and specialized programs for the citizens of the Wiregrass region.

## UNIVERSITY LOGO

The globe and torch is the official logo for the Troy State University System and its components. The following guidelines have been developed by the TSU System University Relations Committee and approved by Chancellor Hawkins to ensure effective and consistent use of the logo:

1. The official logos may appear in one of three configurations:
  - A. the globe and torch;
  - B. the globe, torch and the university wordmark;
  - C. the globe, torch, the university wordmark within two circles.
2. Each logo configuration must be reproduced from authorized reproductions and cannot be redrawn, reportioned, or modified in any way.
3. The official rendering of the globe and torch may be used as a piece of art separate and apart from the circles or wordmark.
4. The complete logo must always be reproduced in the official configuration, completely, not in parts or with any parts eliminated or rearranged.
5. The system or campus name is set in Windsor Bold type.
6. The university logo may be reproduced in two colors (red and black) or all one color.
7. The logo should appear on all university publications and printed materials. The logo may be used as identification on other university-related items such as books, notebooks, sweat-shirts, or other premium items.
8. Camera-ready copies of the logo may be obtained from the University Relations Office in Malone Hall.
9. The official colors of the Troy State University System and its individual campuses are red (PMS 193), black, and enhancer silver.

As stated in previous correspondence, all TSUD publications and

uses of the logo are to be approved by the Vice President for Student Affairs and Development. Members of the Administrative Council have copies of the complete TSU System Visual Identity Program.

Dr. Bae received his bachelor's and master's degrees from the University of Evansville. In 1979, he received his Ph.D. from the University of Southern Mississippi.

Prior to coming to TSUD in September 1986, Dr. Bae was assistant professor and coordinator for the criminal justice program at Louisiana State University in Eunice, Louisiana.
