

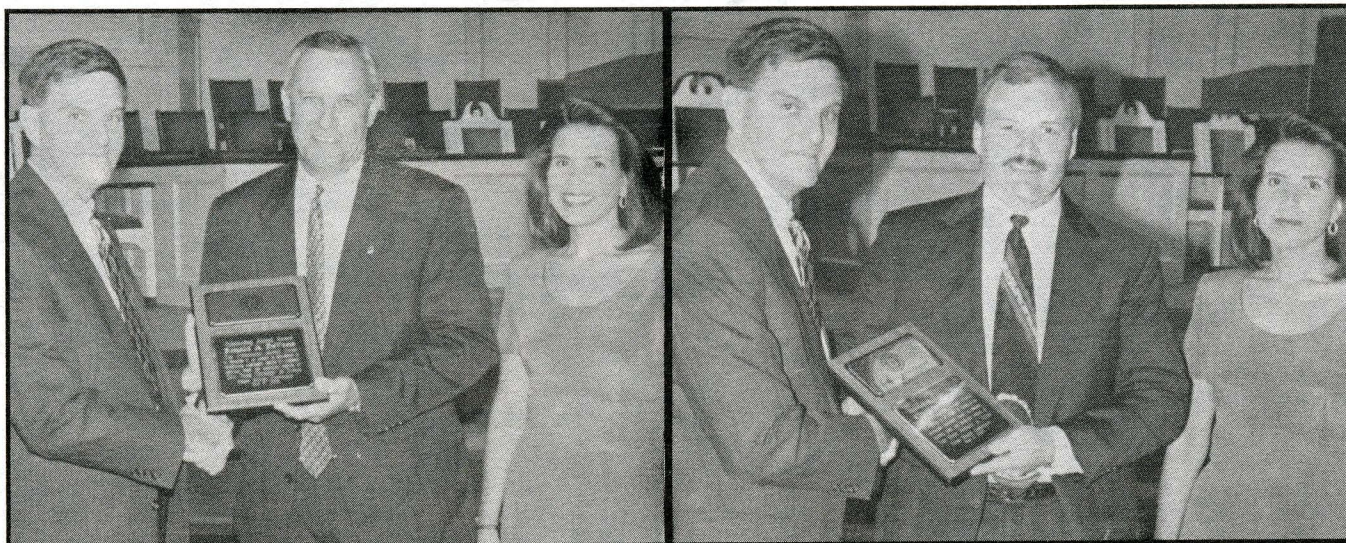

TSUD Honors Alumni

Ronald DeVane, president of SouthTrust Bank of Dothan, was the first honoree for the evening at the recent Spring Honors Convocation. DeVane, a native of Webb, Alabama, graduated from Dothan High School and attended North Florida Junior College. After marrying his wife, Ann, and completing two years of college, he lived in the Dothan area and commuted several times per week to TSU in Troy. It was while taking accounting classes at TSU that he realized he wanted a career in finance. Prior to completing his degree, DeVane was offered a position with GMAC in Panama City, with a guarantee that after a few years he could return to Dothan

where he intended to complete his degree at TSUD. However, he took the initiative when offered a position with SouthTrust Bank, relocated to Dothan, and completed his B.S. degree at TSUD in 1986.

His accomplishments at SouthTrust led to his recent selection as President of SouthTrust Bank in Dothan. He is an active community leader, serving on the boards of the Solid Waste Authority, National Peanut Festival, and the Dothan Rescue Mission. He is a Rotarian and plays a special role for TSUD serving on the School of Business Advisory Board.

Charles Owens, president of Couch, Inc., was the second honoree of the evening. A native of Midland City, Owens graduated from Dale

County High School, attended Wallace College, and graduated from TSUD in 1980 with a Bachelor of Science degree in business administration. Like most TSUD students, he attended classes while having family and work responsibilities.

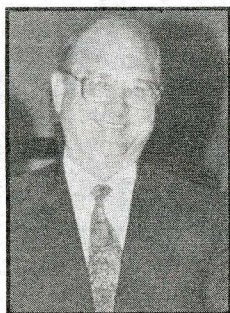
He began a career at Couch Construction as an office manager in 1972. Through his persistence and professional achievement, he progressed in that company and, in 1994, attained the position of corporate president for Couch, Inc. TSUD Recognizes Community Leaders

Two distinguished men from the Dothan Area Chamber of Commerce were presented awards at the Spring Honors Convocation recently. Dr. Thomas Harrison, TSUD president, presented the awards to the 1995 recipients. Harrison said that a community needs individuals who see the future as it could be and who are committed to marshaling the resources to achieve that goal.

Jim Reichardt, president of the Dothan Area Chamber of Commerce since May 1994, was the first honoree for the evening.

Reichardt, a newcomer to Dothan, has sparked the collective imagination of our region by giving direction to dedicated individuals in business, industry, education, and government who comprise the volunteer workforce of the Chamber of Commerce.

Both of these Chamber representatives have brought new levels of "economic proactivity" to this region. Reichardt, Nailen, and the Chamber Board are determined to make the "Dothan by Design" plan a success. For the first time, education has been given its own council, signaling recognition by the business and industry community that economic growth cannot and will not occur without a superb system of education."

TSUD Traffic Accidents

According to Lt. Prichard of the Dothan Police Department Traffic Division, if a traffic accident occurs on private property, the Dothan Police Department will no longer prepare a written accident report. A police unit will be dispatched to the scene and the drivers of the vehicles will be given an "Exchange of Information Form" to be completed and exchanged between drivers. This can be used to provide information to an insurance company. If an accident occurs on private property where there are injuries or the other driver has left the scene of the accident, the Dothan Police Department will prepare a vehicle accident report.

If a traffic accident occurs on University property, please contact the Campus Security at 618-4912. They can assist you in contacting the Dothan Police Department or provide you with an "Exchange of Information Form" for you to complete and exchange with the other vehicle operator. The University does not prepare any type of accident report.

The Professional Development School Partnership enables students and interns at TSUD to observe, on a regular basis, classroom interaction, techniques, and methods used by the practicing teacher. In turn, students and interns are able to interact with the practicing teacher and not only learn to link theory with practice but also to extend to the practicing teacher innovative instructional methods learned in the university course work. 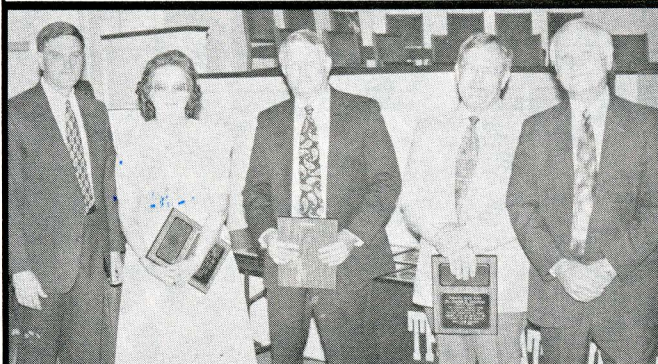

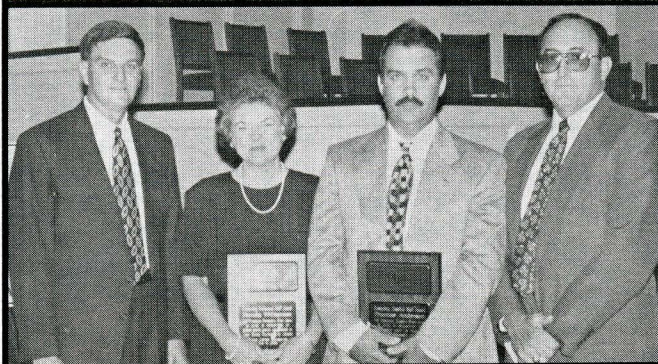

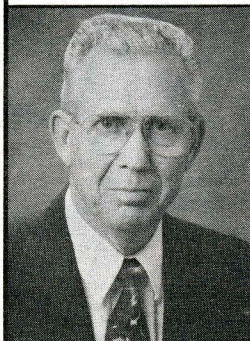
