The Presidential Search Committee held its first meeting on Thursday, January 11, and members reviewed the 42 applications for the position of TSUD president. The process of narrowing the field of candidates has begun. The Committee met on Thursday, January 18, and will meet again on Thursday, January 25, to further refine the list of candidates.

It is anticipated that finalists will be on campus for interviews prior to mid-February, and each finalist will be expected to make a presentation to interested faculty and staff.

Strategic Planning Update

The Strategic Planning Committee (SPC) has successfully completed gathering data and refining the data into factors, planning assumptions, strategies, and objectives. University and departmental objectives were due to vice presidents and deans on January 15. Vice presidents are to complete their review of departmental objectives by January 19. The final draft of the strategic directions and objectives are to be mailed to members of the SPC on January 26 with the final meeting of the SPC to be held on Thursday, February 1.

Dr. Patterson reports that the strategic planning process is moving according to schedule and should be to the chancellor for his review by February 8.

TSUD administrators attend SACS

Dr. Doug Patterson, Dr. Barbara Alford, and Dr. Jack Sublette took part in the 100th Annual Meeting of the Southern Association of Colleges and Schools in Atlanta, GA, December 10-13. More than 2,500 delegates attended workshops and seminars on more than 100 topics, took action on accreditation issues, and set policy for the regional accrediting agency.

Dr. Alford and Dr. Sublette made a presentation at the conference. Titled "Integrating Mission, Student Services, and Technology at a Small University," the presentation focused on techniques for unifying the seemingly disparate elements of institutional identity, student services, and technology. The presenters emphasized that successful institutions in the 21st century will be those that have intergrated these diverse issues.

Troy State University's International Student Cultural Organization (ISCO) will present an "Olympic Fest" at 7 p.m.,


Saturday, February 24, in the Adams Center


