TSUD INCREASES MARKET AREA WITH NEW STATE LEGISLATION

The Alabama Commission on Higher Education (ACHE) and the TSU Board of Trustees recently approved eligibility of out-of-state students who will receive in-state tuition rates prescribed by ACT 96-663 of the Education Reform Act of 1996 passed by the State Legislature in May. Section 4.(b) states that the governing boards of each four-year public institution of higher education shall retain the power to extend resident tuition rates to students who reside in any county within fifty miles of a campus of the institution.

Counties within the TSUD service area include: **GEORGIA**--Baker, Calhoun, Clay, Decatur, Early, Miller, Quitman, Randolph, Seminole; **FLORIDA**--Bay, Calhoun, Holmes, Jackson, Washington, Walton.

How will this legislation affect TSUD? "TSUD has, in the past, recognized seven of these counties within our service area," said Tony Whetstone, director of university relations at TSUD. The most significant impact should come from Decatur County in Georgia, home of Bainbridge College. "Time and time again, students refer to convenience, caring attitude, flexible schedule of course offerings, and quality instruction as reasons for choosing TSUD. I anticipate a greater number of students enrolling from the Florida area because of similar reasons. We have a number of students who transfer from Chipola Junior College in Marianna," added Whetstone.

DR. FRANK LOVRICH RETIRES FROM TSUD

Dr. Frank Lovrich, vice president for academic affairs and dean of the Graduate School at Troy State University



Dothan, has announced his retirement, effective September 1, 1996. Lovrich has been with TSUD since 1976, serving as professor of sociology, dean of the College of Arts and Sciences, and director of Institutional Research and Planning before assuming the position of chief academic officer in 1991.

During his tenure at TSUD, he has assisted the University in accomplishing Southern Association of Colleges and Schools (SACS) accreditation, State Department of Education reaffirmation, National Council for the Association of Teacher Education (NCATE) accreditation, and Association of Collegiate Business Schools and Programs (ACBSP) accreditation.

"It's been an exciting twenty years for me. It isn't often that a person comes into a situation and takes part in the growth of a new university," said Lovrich. "It's amazing what this institution has accomplished by prudent planning despite limited financial support from the state. The strength of

TSUD is in its personnel: its faculty, staff, and administration," he added. Lovrich went on to say that he was glad to be able to contribute to the development of higher education in the Wiregrass area.

As for the future, Lovrich feels that the Wiregrass and TSUD have a bright outlook. "I'm convinced that the future of the Wiregrass can be bright if we all pull together, put aside existing petty jealousies, cooperatively pool our resources, enter into new partnerships, and make education at all levels a high priority. Education is the key to our economic future. The kind and quality of educational programs offered in our schools will determine the rate and character of the region's economic development. The citizens of Dothan and the Wiregrass can have economic development and a high quality of life if they work together, insist on their fair share of state and federal funding, and hold all their elected officials responsible for their job performance," said Lovrich.

A person of Lovrich's enthusiasm and expertise finds it difficult to retire from education "cold turkey." He plans to teach on a part-time basis at TSUD and do some baseball scouting for his younger son, Marty, who is the assistant baseball coach at Auburn University in Montgomery (AUM). His older son, Bill, is a science teacher/baseball coach at New Brockton High School. Lovrich and his wife, Billie Anne, social studies teacher at Rehobeth High School, also plan to do some traveling during their time off together.

DEAVERS PROMOTED TO SENIOR FINANCIAL OFFICER AT TSU

Dr. Kenneth Deavers, vice president for financial affairs and administration at Troy State University Dothan (TSUD), has been promoted to senior vice president for financial affairs at Troy State University (TSU), effective September 1, 1996.



Prior to coming to TSUD in July 1989, he was associate dean of administration and finance at Enterprise State Junior College

(ESJC). Deavers received his bachelor's and master's degrees from TSU and his AA certification in secondary school administration and leadership from Auburn University. In 1987, he received his Ed.D. from Auburn University.

He was nominated for the Outstanding Professional Staff Member of TSUD in 1991, the Chancellor's Award as Administrator of the Year in the Alabama College System, was a recipient of the Southern Association of College and University Business Officers Memphis Workshop Fellowship, and was a recipient of the Columns Award while at ESJC.

Dr. Michael Malone, TSUD president, said, "Dr. Deavers will be sorely missed. Since 1989, he has provided strong day to day leadership for TSUD. His unique talents and experience have been long recognized by those who work closely with him. The design and

construction of our beautiful campus could not have occurred without his eye to detail and perseverance."

Regarding his departure from TSUD, Dr. Deavers said, "It has been my pleasure to be a part of the growth and development of TSUD for the past seven years. I look forward to a continued association with the TSUD community as I assume a new position with The Troy State University System."

He and his wife, Karen, media specialist at Hillcrest Elementary School in Enterprise, have two sons: Michael, an aerospace engineer with TCS Design and Management Services in Warner Robins, GA; and Matthew, an 8th grade student at Dauphin Jr. High School in Enterprise. Deavers and his family are members of the First United Methodist Church in Enterprise. In his spare time, he enjoys fishing, hunting, and collecting sports cards.



TSUD HONORS RETIREES

A retirement reception was held recently to recognize four individuals who have contributed 101 years of service to Troy State University Dothan (TSUD). Honored for their outstanding contribution to TSUD and to higher education were: Dr. Frank Lovrich, 1976 - 1996, vice president for academic affairs, dean of the Graduate School, and professor of sociology; Mr. Hillman Batchelor, 1965 - 1996, associate professor of accounting; Dr. Mary Ann H. Brown, 1971 - 1996, professor of science and mathematics; and Dr. John Woodham, 1971 - 1996, professor of history.

Dr. Elizabeth Van Loo, professor and chair of the TSUD Promotion and Tenure Committee, provided comments regarding Emeritus status for retirees. According to the TSUD Faculty Handbook, Emeritus rank may be assigned to assistant professors, associate professors, or professors who have limited or terminated their responsibilities as a faculty member for valid reasons after ten or more years of distinguished service to the University. Dr. Michael Malone, TSUD president, made a formal Emeritus presentation to each retiree.

TSUD ASSISTANT PROFESSOR CHOSEN FOR GOVERNOR'S ENHANCEMENT TEAM

Alabama Governor Fob James has appointed Dr. Patricia Nelson, assistant professor of special education at Troy State University Dothan, to the

Program Enhancement Team's Support Services Group of the State Workforce Literacy Development Council.

Governor James, through Executive Order, appointed the Council to develop a five-year plan to eradicate illiteracy in Alabama. The plan must be presented to the Governor, Lieutenant Governor, State Board of Education, and Legislature by January 31, 1997.

Dr. Nelson, notified through a letter from State Superintendent Ed Richardson, was selected because of her experience in special education and for her reputation. "I was

tremendously pleased to be appointed to this state team. I like to be a part of where I live; I like to contribute. I've been involved throughout my career at the state level in Kentucky and in my home state of Oklahoma," said Dr. Nelson.

Dr. Betty Anderson, dean of the School of Education at TSUD, said, "Dr. Nelson will bring a great deal of experience and knowledge to this group. It's great for the School of Education and for Troy State University Dothan to be a part of this important process."

TSUD GRADUATE PRAISES HER TSUD EXPERIENCE

Linda Michelle Mincey, Miramar, FL, wants everyone to know that she came through one of the best early childhood education programs in the country. A kindergarten teacher at Allapattah Elementary School in Miami, FL, Linda began teaching in the middle of the school year as a replacement for a teacher who moved.

Other teachers in the school began noticing how visual her classroom became and asked how she developed all her ideas. "The other teachers commented on how bright and colorful my room was and how I had incorporated poems, nursery rhymes, and "Big Books" into my classroom setting," she said. 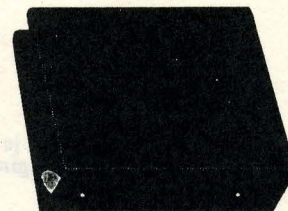
