TECHNO-TEAM INTRANET/INTERNET UPDATE

During the month of December, TSUD made significant progress towards its goal of Internet connectivity. The wiring infrastructure has been completed. The electronics have been installed and tested. The student computer labs in the School of Business and the Instructional Support Center have been configured for networking. Once the network becomes operational, the labs will be ready to be connected. The network servers and software have been ordered and several items have already arrived.

In addition, the new Continuing Education Pentium-based computer lab at Northside Mall has been configured to provide network laser printing and network management of software installation and upgrades. The lab is operational and is currently being used for

courses. The new network capabilities provide to Continuing Education the opportunity to expand their offerings of network-based courses.

During Winter Quarter 1997, two key activities are scheduled. The first activity is the selection of an Internet service provider. TSUD has sent out a Request for Bid to a number of Internet service providers. By early February, the selection process will be finalized. Once the provider has been selected, it will take the provider from four to six weeks to install and configure the hardware and software for Internet access.

The second key activity is the installation, configuration, and testing of the network servers and software. This process includes the development and testing of opera-

tional procedures, such as network backup/restore and virus protection, to ensure network availability. If all goes according to plan, these two activities should be completed by early Spring Quarter 1997. More updates will follow as TSUD moves closer to its goal of becoming "your online community university."

Who speaks for the colleges of Dothan?

Recently I addressed Monday Rotary and Wednesday Kiwanis clubs on my favorite topic--TSUD. I gave them an update on our strategic plan, emphasizing our quality and partnership objectives. I then asked a very important question of my audience, "Who speaks for the colleges of Dothan?"

As we move into our capital campaign major gift solicitation in the external community and our faculty/staff gift solicitation in the internal community, I am very mindful of this important question, "Who speaks for the colleges of Dothan?" As we move into what will surely prove to be a typically rancorous legislative session, I will also be mindful of this important question, "Who speaks for the colleges of Dothan?"

It may beg the obvious, but I know the readers of **LOGOS** resoundly speak for at least one of the colleges and hopefully both! But I submit that local and vocal support for higher education in general, and our community institutions specifically, is critical. As I commented to our graduates at fall commencement, higher education in Alabama is under assault. Your local and vocal support is critical.

With regard to the capital campaign, you can "speak volumes" by making your gift to TSUD (over a 3-5 year period) when we kick off our faculty/staff solicitation on March 1, 1997. With regard to our legislative agenda, you can "speak volumes" by your verbal and written advocacy in support of our special equity funding (ACHE's recommendation of an additional \$1.2 million for TSUD and similar allocation for our sister school in Montgomery).

When I ask external community groups, "Who speaks for our very special academic enterprise?", I need to be able to say, "Our faculty and staff most assuredly do," as evidenced by their 100% contribution rate for the TSUD capital campaign. Several of my colleagues have already "voiced" their support for our very special enterprise through their monetary contribution and verbal and written support to our Wiregrass legislative delegation in support of our special equity funding.

Will you raise your voice and speak? The assault on Alabama higher education has begun and silence (from those who really count) can be a deadly assault weapon!

DR. MALONE SELECTED FOR GOVERNOR'S COUNCIL

Dr. Michael Malone, TSUD president, has been selected by Governor Fob James to serve on the Governor's Council on Education Technology (GCET). Also serving on the GCET is Dr. Andrew Sorensen, president of The University of Alabama.

The GCET was created as part of the Governor's Information Technology Commission. The focus of the Council will be to establish a unified plan for a technology based learning environment that will increase the teaching and learning productivity of students and teachers and, thereby, produce students with the range of academic knowledge and skills necessary to adapt to emerging technologies and become productive citizens in a highly competitive global society. This unified plan is to ensure implementation of technology applications and programs with the capability to demonstrate increased student achievement in the major academic subjects. The accomplishment of these goals requires development of support, mentoring, and sustained ongoing training programs for educational staff, teachers, and students through integration of state-of-the-art computing and telecommunications technology.

The Council has met on several occasions and has begun work on a technology plan for K-12 with linkage to higher education. The plan is to design connectivity such that all public schools and classrooms in the State of Alabama have Internet and intranet capabilities. "It's a bold, ambitious plan to bring connectivity to all the state's classrooms. The State of Alabama is starting behind its neighbors with this endeavor, but whenever this plan is funded and enacted it should reflect the quality of the school plans from Georgia and Tennessee," stated Malone.

Other members of the GCET include the State Superintendent of Education as chair, the State Finance Director, Chairman of the Alabama Supercomputer Authority, the Chancellor of the Department of Postsecondary Education (or designee), two media specialists, and five K-12 personnel to include at least three classroom teachers and two school administrators.

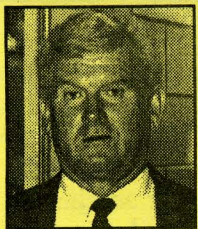

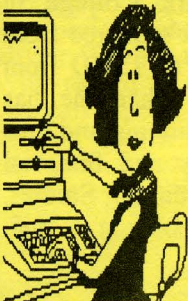
Brown

Critical Language Program Working Well

TSU's Critical Language Program is doing more for its students than simply teaching a foreign language. It is bringing a piece of the native country to TSU.

"Critical language is a term used by the National Association of Self-Instructed Programs," said Dr. Curtis Porter, dean of International Programs. "It was started at TSU in the fall of 1996 and is a way of teaching a foreign language without hiring a full-time faculty member.

A native speaker is hired from his or her country as the instructor, and for one academic year students have the opportunity to learn a foreign language in a unique manner. "The program takes an oral approach rather than a written or literary one," Porter said. "This program offers students the opportunity to learn an appreciation of how people in other cultures differ and how to be sensitive to these differences in order to be more effective in business," added Porter.

German was offered fall 1996. Japanese and Russian languages are scheduled for the future.



TSUD RECEIVES RECOGNITION

In recognition of its commitment to adult education and to the businesses in the community, TSUD has been presented the CLEP 1996 Rekindle the Flame Award by The College Board for participation in the Winning Edge Campaign of the College-Level Examination Program (CLEP). TSUD joined Auburn University and The University of Alabama at Birmingham as one of three higher education institutions in Alabama to participate in this program. TSUD is the regional CLEP testing center.

Pamela Williamson, director of counseling services at TSUD, said "Besides offering the CLEP, we notified businesses through our recruiting office that adults, their employees, could receive college credit by taking the test. Businesses were made aware that they could sponsor their employees to take the CLEP," added Williamson.
