
TECHNO-TEAM INTRANET/INTERNET UPDATE

During the Winter Quarter 1997, TSUD finalized the last component for Internet connectivity. In early February, the University sent out a Request for Bid to a number of Internet service providers. DeltaCom, a southeast regional long distance telecommunications company

based in Alabama, was awarded the bid in early March.

DeltaCom has started the process of scheduling the installation and configuration of the hardware and software for Internet access. This process will take approximately four to six weeks. If all goes according to plan, TSUD will turn on the switch for Internet access in mid-April.

PRESIDENT'S MESSAGE

When our new building is finished; when TSUD students benefit from additional scholarship money; and TSUD faculty benefit from new professional development opportunities, we will reflect back on these few weeks in March when so much was asked of so many.

Dr. Matthew Valle announces the publication of a research study conducted with Dr. Micki Kacmar of Florida State University in the journal Educational and Psychological Measurement. The manuscript titled "Dimensionality of the Measure of

of the Measure of Ingratiatory Behaviors in Organizational Settings (MIBOS) Scale" will appear in the April 1997 issue (Vol. 57, No. 2). The content of the analysis may not be of particular interest to faculty members, but the conduct of the research may interest anyone who deals with scale development and validation.

The research made use of LISREL analysis to investigate the structure of four proposed scales used to measure (ingratiatory) influence behaviors.

Dr. Valle would be pleased to discuss this analysis or any other use of LISREL with anyone who would like more information.

Library News

On March 24 and 25 the Network of Alabama Academic Libraries will host a "Database Showcase for the Virtual Library" at Auburn University. Representatives from the TSUD Library will attend. A description of some of the databases to be showcased and selected for inclusion in the Virtual Library are as follows:

ABI Inform - Covers business and management topics including company histories, competitive intelligence, and product development. Topics include advertising, banking, broadcasting, computers, economics, foreign investment, health care, international trade, management, marketing, taxation, etc. Contains citations to over 1,400 U.S. and international journals from 1971 to the present. Full text of articles will be available for over 700 of the journals indexed.

Academic Press Journals - A science and social science journal library consisting of abstracts and full-text articles from 178 Academic Press journals. Coverage includes accounting and management, computer sciences, mathematics and engineering, social and behavioral science, physics, chemistry, and the physical sciences.

Applied Science and Technology Abstracts - Provides bibliographic references in aeronautics, computer sciences, waste management, geology, physics, textiles, and food technology.

Art & Humanities Search - Provides citations to articles from more than 1,300 arts and humanities journals and to relevant articles on arts and humanities in over 5,000 social science and science journals.

Biology Digest - Covers all the life sciences. Specially created to meet the needs of college undergraduates. Indexes and provides abstracts to over 300 journals.

Business Dateline - Covers topics such as agriculture, company profiles, corporate strategies, executive profiles, financial services, high technology, manufacturing, marketing, regional business environments, retailing, and the service industries. Contains full-text articles from over 450 sources including major newspapers.

Education Abstracts - Covers 400 English language periodicals encompassing all aspects of education including administration, teaching methods, and curriculum.

Entomology Abstracts - Includes systematics, phylogeny, morphology, physiology, anatomy, biochemistry, genetics, biology, etc.

WorldCat - World's most comprehensive bibliography with bibliographic records representing information spanning 4,000 years of knowledge. Coverage: Approximately 2150 B.C. to present.

GAMMA BETA PHI



TSU Celebrates 110th Anniversary

On February 26, 1887, the Troy Normal School was founded in a particularly hilly section of Southeast Alabama. Now, 110 years later, Troy State University takes time out in the Alabama state capital to celebrate all it has achieved and all which is yet to be done.

On February 26, 1997, TSU unveiled a display detailing the lifeblood of the university. The unveiling took place in the RSA Commerce Building in Montgomery. The elements of the display included a look at all of TSU's colleges and schools, prominent alumni, student activities, the Sound of the South, athletics, and the economic impact TSU has made on the city of Troy and Pike County.

TSUM Receives Grant from BellSouth
