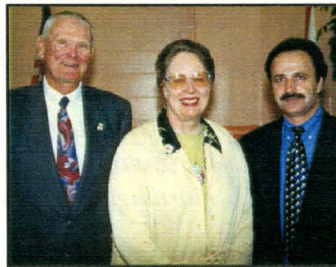

TSUD INVITATIONAL GOLF TOURNAMENT RAISES \$10,000 FOR SCHOLARSHIPS

Under the auspice of clear skies and a great turnout, the first annual Troy State University Dothan Invitational Golf Tournament carded an "Eagle" last month for University scholarships at Dothan's award winning Robert Trent Jones Golf Trail, Highland Oaks course.

The Thursday, September 27, 2001, tournament sponsored by Jackson Thornton Technologies LLC, Mayer Electric, Sodexho, Dairy Fresh, Waitt Outdoor, Photorama, Scenic Cable, WOOF 99.7 FM, and other local sponsors helped raise more than \$10,000. Monies raised from the tournament will go into the TSUD Alumni Association Scholarship account and the TSUD General Scholarship Fund.

"This is a great day for our University and our community," said TSUD President Michael Malone, noting the more than 213 tournament participants and 136 golfers that competed in the 18-hole, four man scramble. "This (tournament) really says a lot about us and what this community can accomplish when working together for a common cause, such as raising support for scholarships so a young person might have an opportunity to receive a college degree."

The tournament, initiated by the TSUD Alumni Association Executive Committee during April 2001, took its direction by the establishment of a 26-member golf committee, comprised of TSUD alumni, friends, and University staff.

"I am elated over what this committee has done in preparation for this tournament," said Debora Pettway, TSUD Alumni Association President. "I am also thankful for the support received from Dr. Malone, Dr. Alford, our faculty, staff, and students. The Executive Board and I want the golf tournament to become an annual event, although we are not sure how to top this one! September 27, 2001 was truly a mark in history for the TSUD Alumni Association."

On September 10, 2001, the immense Troy State University bus rolled into Dothan. Troy State alumni and other public dignitaries such as TSUD President Michael Malone, TSUM President Cameron Martindale, and the Chancellor of The Troy State University System, Dr. Jack Hawkins, Jr., filled the bus.

The bus tour made stops in 11 cities including Ozark and Dothan. The tour stop in Dothan was held at Millennium Park in downtown Dothan. 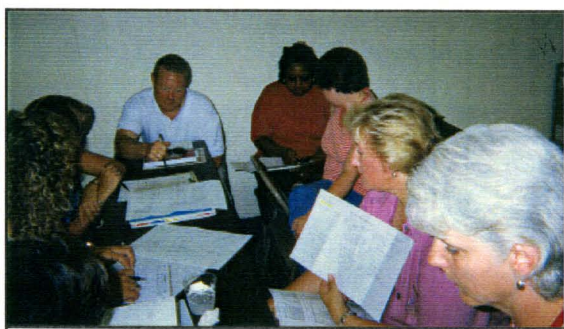

1999 NEW AND IMPROVED OFFICIAL DEFAULT RATES OF 3.6 FOR TSUD

TSUD has received their 1999 Default Rate Report of 3.6% from the U.S. Department of Education. These rates are published each year. All schools must stay under a 25% default rate to continue in the loan program without being subject to sanctions or losing their program. Jonua Byrd, director of financial aid and veterans' affairs, stated, "At TSUD we have continued to strive for educating our students on the loan program from the beginning to end. Each student must complete an On-Line Entrance Counseling process prior to having a loan completed. This ensures that the student understands a loan must be repaid after leaving school, graduating, or dropping below half-time status. Each year a student must reapply for a new loan by completing the Free Application for Federal Student Aid (FAFSA), and in about six weeks they receive a student copy called the Student Aid Report (SAR) that will list all loans received. This information will help the student understand the estimated indebtedness and their approximate repayment on their loan obligations. The upfront counseling that Alex McMahan gives each loan student that comes into his office and the continued effort that Janet Ridgeway puts into ensuring their paperwork is accurate is the reason that TSUD's default rate has not increased this year. Alex and Janet both put forth 100% in their efforts to insure that students receive all their information in a timely manner. Our students at TSUD are very responsible and understanding about their loan obligations."

LIBRARY NEWS

| 1969-1971 | A coordinator of library services was employed by TSU/Fort Rucker. 1,700 books were brought from the Troy Campus Library, shelved together in the Center Library on post, and the coordinator served as reference librarian for anyone needing assistance. |
| 1973 | TSU/Fort Rucker established its own library in a renovated former barracks, Bldg. 601 at Fort Rucker. |
| 1976 | TSU Dothan Library Services began in 1976. An agreement was reached with the public library to provide space to house materials. Audio-visual equipment was kept in Houston Hall. |
| 1979 | All audiovisuals, periodicals, and indexes were moved to the 7 th floor of Houston Hall. In the same year a curriculum lab was developed as well. Books were still located at the public library location. |
| 1983 | All 7 th floor operations (excluding curriculum lab and audiovisual services, which remained) and the public library operations were consolidated in a newly purchased building at 304 N. Foster. |
| 1985 | All operations at 304 N. Foster were moved to 315 N. Foster. |
| 1986 | Fort Rucker Library Operations consolidated with Dothan operations. Fort Rucker Library closed. |
| 1990 | Occupied 2 nd floor of Adams Hall at new campus on 231 North. |
| Sept. 2001 | Anticipating move across the quad to the Library/Technology Building. |

Dr. Barbara Gusick's article "Ambrose's Idea of God's Superabundance and the Construction of Work in the Towneley Cycle" was recently published in Vol. 7 of *Publications of the Medieval Association of the Midwest*; she also presented a paper entitled "Theatricality and Thaumaturgy in the York Entry into Jerusalem" at the 17th Annual Conference of the Medieval Association of the Midwest, held at the University of Wisconsin (Madison).

Dr. Sandra Lee Jones co-presented poster session on the "Student Technology Corps," with Dr. Robert Melczarek at Merlot International Conference in Tampa, FL, on August 13-14; served as the teacher education member of a focus group on a McGraw-Hill project to redesign their web site on August 14; hosted a concurrent session at Merlot International Conference in Tampa, FL, on August 15; co-presented with Dr. Darrell Pearson of Troy State University a Showcase of Technology Best Practices session on MERLOT at the Alabama PT3 Technology Resource Development Summit in Birmingham on September 20.
