Narcissism: An Overview of Symptoms and Possible Treatment

Description: Narcissism and narcissistic personality disorder can be very destructive. Clients often come to professional counselors because of the hurt they have suffered from having been in a relationship with a narcissist, and narcissists sometime come into counseling because of the hurt they have experienced as a narcissist. Professional counselors are the frontline in helping both types of clients. This presentation brings some perspectives to the table about identifying the symptoms, the impact, and some possible helps for both the counselor dealing with narcissistic clients or those wounded by narcissists.
